

## COYOTE POINT RIFLE AND PISTOL CLUB

### NRA FIRST STEP PISTOL

The Coyote Point Rifle and Pistol Club promote responsible gun ownership and practices. In our NRA First Step courses we strive to develop safe firearm handling skills for the individual with little or no experience with modern firearms.

NRA First Step classes will be held the first Monday of every month starting in April and ending in September. Each class will provide beginning shooters with an introduction to the knowledge, skills, and attitude necessary to own and use a modern firearm safely. Each class will introduce the student to rifle/pistol safety, parts and operation, an introduction to ammunition and the fundamentals of shooting, followed with an introduction to cleaning and storage. A total of 3 hours will be spending in the classroom and on the range. The instructors will provide firearms and ammunition. We will use .22 caliber rifles and pistols only. *You may bring your personal firearm to the class to learn how it functions and how the safety works. Make sure your firearm is unloaded before coming to class. Do not bring any personal ammunition to class.* You will use only the ammunition and .22 caliber rifles or pistols provide by the instructor. Hearing and eye protection will be supplied by the instructor.

#### SELF-CERTIFICATION FOR ADULTS and RELEASE FORM

Effective September 30, 1996, Congress enacted the Omnibus Consolidated Appropriations Act of 1997 entitled "Gun Ban for Individuals Convicted of a Misdemeanor Crime of Domestic Violence." The law prohibits any person who has been convicted of a "misdemeanor crime of domestic violence" from possessing, or receiving firearms or ammunition. In addition the law prohibits any person with a "domestic violence restraining order," from possessing, or receiving firearms or ammunition. Please complete the Self-Certification form and bring it to the first class meeting.

Please print, read and bring the Public Use Release form to class. You may fill out the form before class but do not sign the form.

#### CONSENT FORM FOR A MINOR

If the student is a minor to comply with the applicable California Law related to the use of a firearms and the possession of live ammunition by a minor the minor consent form and release waiver should be completed and brought to the first class.

The undersigned agrees he or she has read, understands and agrees to all public rules and regulations and safety procedures for the facility.

For use of the facility for which it is intended, the undersigned agrees to indemnify, defend and hold harmless the County of San Mateo its officers employees or agents, the Sheriff of San Mateo or his agents against any and all liability, claims, demands, damage, causes of action, suits or judgments, including attorney's fees and all costs and expense incurred in connection therewith, because of any loss of any kind whatsoever by reason of injury or death of persons, or damage, or damage to or destruction of property including property of the County of San Mateo, and or the Sheriff of San Mateo and his agents unless such loss, costs, liability, damage or expenses is due to the sole negligence or willful misconduct of the County of San Mateo or the Sheriff of San Mateo or his agents. Such agreement is effective immediately upon signature and date and is binding not only to the undersigned but also upon all administrators, assigns, employees and successors in interest. The duty of the undersigned to indemnify and hold harmless, as set forth herein, shall include the duty to defend as set forth in all statutes.

A minor cannot possess a concealable firearm or live ammunition, no matter what the caliber the ammunition may be unless his or her parent or legal guardian accompanies him or her. There are two unique exceptions to this rule.

1. A responsible adult 21 years of age or older may substitute for the parent or legal guardian buy only with prior written consent from the parent or legal guardian.
2. If a minor is at least 16 years of age they do not need to be accompanied by a parent or legal guardian, or a responsible adult 21 years of age or older however the minor must have prior written consent from the parent or legal guardian.
